Wizards Of The Coast Product Dealer Agreement

This Dealer Agreement (this "Agreement") is made this _____ day of _____, 2007, by Global Sales Wholesale ("Global Sales") and all WotC Authorized Global Sales affiliated Companies and _____ ("Dealer").

Whereas, Global Sales and Dealer desire to enter into this Agreement, and whereas, Dealer desires to purchase Wizards of the Coast product from Global Sales and Global Sales desires to sell Wizards of the Coast product to Dealer.

1. Now, therefore, it is hereby agreed that by signing this agreement, Dealer is attesting that Dealer agrees to be held to the definition of Dealer as defined below.

Dealer is defined as follows:

- a. An adventure/hobby game, comic or collector card business that purchases Products for resale directly to consumers by way of a physical retail outlet owned or operated by such adventure/hobby game, comic or collector card business.
- b. "Dealer" specifically *excludes* Subdistributors or any person, including without limitation, any person or Mail Order business that purchases Product for sale primarily via the Internet or primarily other means of electronic transmission, or any person that purchases Products for sale other than directly to a consumer.
- c. A majority, over 50%, of this business is derived from this **Physical Retail Store Location open regularly for business to Consumers.**
